Sri Somanath Pradhan, Sub-Collector and President presided over the meeting and the following resolutions were passed after elaborate discussion.

RESOLUTION -1

The recommendation of the screening committee for sanction of MACP of staff of retired and present staff of NO. 13 as allowed by the Principal is approved. (Annexure- A)

RESOLUTION -2

It is approved to advance the employment expenditure for a sum of Rs. 10000/- to Principal in view of preparation of NAAC, affiliation and other contingency expenditure which will be met out of +2 Management. The advance be adjusted after submission of utilization of bills.

RESOLUTION- 3

It is approved to utilized necessary prescribed fees for opening of new courses i.e. +2 Commerce, P.G. in English, Odia, History, Pol.Science, Chemistry, Zoology, Physics, Botany & Mathematics and increase of seats to 32 in English Honours. The Principal is authorized to take necessary step towards deposition of fees and submission of proposal to the concerned authority.


RESOLUTION- 4


The recommendations of IQAC for improvement and renovation as follows is hereby approved.

- i. Installation of solar back up system for RUSA building with approximate cost of Rs. 2 Lakhs to be borne from +3 Student Fund
- ii. Improvement of playground cost Rs. 35000 from +3 Management fund
- iii. Improvement of Garden & beautification of campus- Rs. 60000 form +2 Management Fund.
- iv. Organising seminar at Department level Rs. 60000 from +3 Student Fund.
- v. Activation of Placement Cell Rs. 20000 from +3 Student Fund.
- vi. Subscription of INFLIBNET for downloading journals- Rs. 10000/- (Library) student fund
- vii. Completion of automation of Library works- Rs. 40000/- from +3 Management

RESOLUTION- 5

A sum of Rs. 50000/- out of +3 SF is hereby granted to conduct the IQAC Seminar over and above the grant of 1 Lakh provided by NAAC as to conduct the seminar. The sanctioned grant of one lakh is not sufficient to organize the seminar. Principal is also authorized to spend Rs. One Lakh form College +3 Management fund as advance to conduct the seminar properly as per the NAAC guideline and to reimburse the amount of Rs. 1 Lakh from NAAC after conducting the seminar.

RESOLUTION-11



RESOLUTION-12


